It will feature Sorbonne University that discontinued institutional subscriptions to both the Web of Science and Clarivate's bibliometric tools, choosing instead to redirect its efforts towards open, free and participative tools, in particular OpenAlex, and its work on open science infrastructures. The session will also feature incentives at Utrecht University to promote open science, highlighting how recognitions and rewards have been integrated into the institutional open science programme, how the TRIPLE model for assessment criteria has been embedded in human resource management, why the Journal Impact Factor has been abandoned in hiring and promotion decisions, and why and how Utrecht University has decided to move away from university rankings.
